The Democratic Socialist Republic of Sri Lanka has received financing from the World Bank toward the cost of the Sri Lanka Primary Healthcare System Strengthening Project, and intends to apply part of the proceeds toward payments under the contract for the construction and installation of 26 Nos of air-conditioned cargo drug stores with solar power at health Institutions island wide.
- 2. The Project Director of the Primary Healthcare System Strengthening Project on behalf of the Project Procurement Committee, now invites sealed Bids from eligible Bidders for the construction and installation of 26 Nos of air-conditioned cargo drug stores with solar power at health Institutions island wide.

Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, revised November 2017 and August 2018 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
- 4. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the requirement of Public company / Bureau / Private Company / Partnership/ Sole proprietor with valid registration of relevant Authorities.
- 5. Bidder shall quote one or more lots. Documentary evidence must be submitted for previous client references within the Sri Lanka together with the Bid.

- 7. Pre-Bid Meeting will be held at 1000 hrs in local time on 14th December 2021 at the Auditorium of the Primary Healthcare System Strengthening Project, 3rd Floor, J.R. Jayewardene Center, 191, Dharmapala Mawatha, Colombo 07, Sri Lanka at which prospective Bidders may request clarification of the supply requirements. Attendance to the Pre-Bid Meeting is essential.
- 8. A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the address given underneath and produce the original certificate of the registration of the Tender or certified true copy of said certificate (P.C.A.3) issued, from 3rd December 2021 up to 27th December 2021 from 0900 hrs. to 1500 hrs. in local time on week days upon payment of a non-refundable fee of Sri Lankan Rupees (Rs.)10,000.00. The payment will be deposited to the Director General Health Services, Bank of Ceylon, Thaprobane branch Account No: 7040244 and receipt to be produced to collect the Bidding document.
- 9. Bids must be delivered to the address below on or before 1000 hrs on 28th December 2021. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below at 1000 hrs on 28th December 2021.

10. All Bids must be accompanied by a Bid-Security as per the following table. Bid Security shall be an unconditional guarantee issued by a reputable bank.
