Background

The primary health care re-organization process aims to introduce organizational, structural, and logistical updates to the health system designed to restructure primary health care so that it streamlines access to quality, people-center health services, increases the efficiency of these services,

and ensures a continuum of primary care for people throughout their life cycles.

A longitudinal electronic medical record has been identified as an integral part of the information

management mechanism of the primary health care re-organization process.

The Cloud based Health Information Management System (HIMS-Cloud) developed and piloted by the Health Information Unit in collaboration with the PSSP project. The core system needs further expansion and module development to cater the growing needs of primary care information

management; including Healthy Lifestyle Clinics around the country.

The expansion of the HIMS-Cloud to nearly 550 primary care units and 700+ HLC clinics in the

island would require technical support that is required through this consultancy service.

HIMS (Health Information Management System), a cloud-based information management system allows entering all personal information & health information of people registered and screened for risk factors required for risk categorization, appropriate intervention and follow up. At present 350

PMCIs are connected to the system and extended to another 200 minimums in 2022.

With the expansion of the system, it is necessary to have a dedicated person to manage user accounts, manage metadata, and manage institution data. It needs round the clock support and troubleshooting

and conducting on-demand training. Data analysis and report generation are other requirements.

Personal loggings for end users should be prepared and issued, reports should be generated for health planners and attended to all troubleshooting. As the Health Information unit of the Ministry of Health has no designated officer for the above the Project PMU is expected to provide the above technical

support to ensure the project results.

Objective

To maintain the Health Information Management System (HIMS), and attending to its daily administrative functions and troubleshooting to ensure the system sustainability.
