## Revised Guidelines on community engagement and grievance redress mechanism for the **Primary Health Care**

Ministry of Health

The Government of Sri Lanka endorsed a policy in 2018 in order to reorganize the primary healthcare system in Sri Lanka to address the emerging health needs in the country. The policy recommends the establishment of a mechanism for addressing public/patient concerns, suggestions, and complaints. It has also been recognized that there is a felt need for a formal accountability mechanism within the health system of Sri Lanka.

Based on the above key recommendations, guidelines on community engagement and Grievance Redress Mechanism (GRM) for Primary Health Care have been developed by the Ministry of Health in 2018. These guidelines have been used for community engagement in PMCIs for the last four and half years. Based on the learned facts and experiences gained through the period this revised guideline was developed. All healthcare providers under the Ministry of Health as well as under the provincial ministries of health are instructed to follow these guidelines and establish friends of facility committees to enhance community engagement for the successful implementation of reorganization and strengthening of primary healthcare services.

Please note that these guidelines are subject to review and update from time to time, so that you are kindly requested to submit your suggestions to Grievance Coordinating Unit under the Additional Secretary medical services if you feel any amendment is required.
